2015 Federation Convention

I know it is only January, but the time of the annual NARFE Tennessee Federation Convention will be here soon. It will be held April 20-21 this year and in Clarksville TN. Hosting the convention this year are the Clarksville, Dickson and Jackson Chapters.

Early registration runs to March 16th but if you register by February 1st, you will be entered in a drawing for a free nights lodging at the Mainstay Suites in Pigeon Forge. I will bring Registration Forms to the upcoming chapter meetings. You can also find this form on the [Federation website](#). Or if you want, I can mail you a copy. I would encourage your to attend the state convention and meet NARFE members from across the state and learn what other chapters do. There is a cost to attend the convention, you can choose to attend only the business session which is \$25, or the banquet only which is \$25 or both for \$50. The Riverview Inn in Clarksville will be the location, we have used this before and it was a good location. The room rate for NARFE members to stay during the convention is \$84 plus taxes. Delegates are also needed for this convention. All delegates get to vote on any matters that come up during the business session. Legislative news

Congress has just begun a new 2 year session, this is the 114th Congress. For those of you who live in the area in and around Cookeville, we still have the same members of Congress. Below is some NARFE related legislative news pertaining to the last session of Congress:

There was no provisions in the latest budget bill (CRomnibus) that negatively impacts federal employees or retirees.

Congress passed a 5-year extension of the Re-employed Annuitants provisions. This allows agencies to hire retirees on a limited, part-time basis without a reduction in their salary.

Our NARFE Legislative Department with the help of you and other members were able to prevent some actions which would be harmful to federal workers or retirees. Highlights of these are listed:

Prevented the switch to the Chained CPI method of determining our COLA.

Opposed provisions of the Senate postal reform bill, including proposed changes to FEHBP, requirements that USPS retirees enroll in Medicare and changes to the FECA program.

NARFE will continue to work for us in the current session of Congress. Keep your membership active so that we have a GREATER voice in Congress.

In looking over the latest data that I can see in regards to our chapter membership on the NARFE website, I see no additions or dropped members. I do see some who were sent a Second Dues Notice who still have not renewed. If this is you, we would appreciate it so much if you would send in your dues renewal as soon as possible. Remember that if you pay for multiple years (2 or 3), you will save some money when compared to the 1 year rate.

This is a good time to remind you about the savings of going on Dues Withholding. Many of you already are having your NARFE membership dues withheld from your annuity checks. This not only saves you money, but it means you don't have to mail in payments or be bothered by those pesky renewal reminders from the national office or by our chapter. If you are not on Dues Withholding, you can switch at any time and it will take effect at the end of your current renewal period. To make the switch from annual renewals to Dues Withholding, call the national office, 800-456-8410 and tell them you want to sign up for Dues Withholding. Or [click here](#) for the brochure that explains the benefits and form you can fill out and mail in. **You could save up to \$18 over 3 years !!** Every little bit helps.

NARFE magazines
