## COLA watch

With the January Consumer Price Index report, we are 4 months into the current cycle which determines if we see a cost of living increase for 2016. These past 4 reports have all shown a decrease towards a COLA and currently stands at a minus 2.54 percent. The February report will be out by the time of our next meeting, we will see what it shows.

For all the federal retirees, we received a 1.7 percent increase for this year beginning with our January payments.

## Income tax season

It is that time of year again that many are filing federal tax returns. If you are having to pay additional taxes or getting a large refund, you may want to consider making a change in the amount of federal income tax withheld from your paycheck or annuity check. For those still working, your agency or human resource office can help you with that. For those who are retired and receiving an annuity check, the Office of Personnel Management (OPM) is the place to go to. You can call them at 888-767-6738, write them at OPM Retirement Operations Center, P.O. Box 45, Boyers PA 16017 or you can also take care of this online at [www.opm.gov/retire](http://www.opm.gov/retire).

There are many services available on that OPM website that you may want to take advantage of. In order to do that, you will need to have an online account. The website will explain all of that. Besides making changes to tax withholding, here are some of other things you can do online

- Change your mailing address
- Establish an allotment to an organization
- Set up a checking or savings allotment
- Change where your direct deposit is sent to
- View and print the 1099-R forms
- Request a copy of the Annuity Booklet

For those who need help in filing your income tax returns, you can find that generally in your community somewhere, like at a senior citizens center.
