**Notes from Federation Convention**

The 59th Annual Convention of the Tennessee Federation of NARFE Chapters has come to a close. Overall, I think this was a good convention. Attendance was about normal, there were 55 delegates, 9 officers and many other members present.

It all got underway on Monday, everyone was greeted by a group of therapy dogs as they registered. After registration, there were the committee meetings, a legislative training session that included a presentation via a video link with Jessica Klement from NARFE HQ Legislation Department. Monday ended with the banquet and the door prizes.

Tuesday was the official part of the convention and the business meeting. We were welcomed by various local and state elected officials and a guest speaker, Greg Stallworth who is the EEO Officer at Ft. Campbell.

The Keynote speaker was NARFE National President, Richard Thissen. He spoke on several topics which included; Advocacy Advisory issues, Service Officers, Membership, the NARFE magazine, the NARFE database and records, social media, the financial status of NARFE, and the continuing work on the Future of NARFE.

As we have been talking about over the course of the past year, there were several membership and recruiting awards given out at this convention. There are 2 chapter awards given out each year. One is the Weida White Tolley Memorial Alzheimer's Award, it was won by the Cleveland Chapter for making the most donations per capita to this fund. The other was the Leo Potts Memorial NARFE-PAC Award, it was won by the Cumberland County Chapter for the most per capita donations. Both of these chapters have won these awards many times over.

There was a Silent Auction again this year to raise funds for Alzheimer's research. This year, this brought in \$1342 and there were an additional \$491 in donations to this.

There was one resolution considered this year, it was the one that I and the Federation Board have worked on over the past year or more. The resolution called for the adoption of a revised Federation Constitution and Bylaws. With some opposition, this was approved by the delegates. —*continued*

And, of course, there was the election of officers held to lead the Federation over the next year. Like it is for some chapters, it is hard to get qualified members to agree to become an officer. There was no contested positions and elected by voice vote were this list of officers:

All of these officers have served this past year or more with the exception of the 3rd VP. The president for the past 2 years was Larry Henderson. The Federation President position is limited to 2 years and normally the Vice Presidents step up in position and they find someone new for the 3rd VP. There is 1 officer position that remains vacant, that is the Membership Chairman. No one could be found who would agree to serve in that capacity. That is too bad as that is a critical and much needed position.

Next years Convention for 2016 was set for April 25-26 in Pigeon Forge TN. It is a week later than normal due to other events taking place in that location. There were some unusual events at this years convention, but you will have to come to the meeting this month to hear about those.

## Legislative news

Both branches of Congress have been working on the federal budget for the next fiscal year, FY16. House and Senate budget negotiators finalized a joint budget resolution for fiscal year 2016 this week. This highly anticipated conference report is the first time both chambers have agreed on a budget in several years.

While the impact of the joint budget resolution on federal employees and retirees is not as severe as the House budget that passed in March, it still assumes more than \$193 billion worth of cuts from the federal community. The joint resolution also fails to relieve agencies from the arbitrary budget constraints imposed by the across-the-board funding cuts known as sequestration.
