### Legislative news

While thinking about the NARFE-PAC, we need to think about the actions being considered in Congress on legislative news. NARFE headquarters has an outstanding Legislative Department that closely monitors the various bills and proposals before the US House and Senate as well as the US President. They keep us informed and urge us to take action by using its website and phone system to voice our opinions. Here is the latest news that I have on some of the bills being considered.

- ◆ **WEP Reform**—NARFE members are asked to contact their Representative on H.R. 711 to urge them to support this bill. I contacted Rep. Black and she indicated her support for it. This bill will help somewhat for those starting Social Security benefits going forward (2017 and after), by reducing the current penalty. This will provide some relief for SS beneficiaries. NARFE continues to support the full repeal of WEP but that seems unlikely to succeed.
- ◆ **FY 2017 Budget**—Both the President and the Congress are working on the next fiscal year's budget proposals. We have details of the President's plan which calls for a 1.6 percent pay raise for federal employees, does not include an increase in retirement contribution, it also does not call for cuts to the Federal Employees Compensation Act which affects those work related injuries or sicknesses.
- ◆ **Federal Adjustment Income Rates Act**—H.R. 4585 would provide for across the board 3.9 percent federal pay raise, with an additional 1.4 percent for locality pay adjustments. NARFE supports this bill.
- ◆ **Federal Employee Rights Act**—H.R. 4461 as introduced would undermine the rights of federal employee unions and could lead to negatively impact organizations like NARFE in the future. NARFE is saying it opposes this bill because the measures are unnecessary and present a misleading image of how federal employee unions conduct their business.
- ◆ **OPM Director**—Beth Cobert who has been nominated to become the new OPM Director after the resignation of Katherine Archuleta is one step closer to being confirmed. The Senate Security and Governmental Affairs Committee has approved her nomination. She awaits consideration by the entire Senate.

So for these bills and others is why NARFE desires a strong voice in Washington. Also noteworthy is the emphasis on legislation which affects federal employees, NARFE is working hard for this group.

### 2016 NARFE Conventions

We are just one month away from the Tennessee Federation Convention, there is still time to get registered to attend. I would encourage you to do so. The state conventions are enjoyable, you get to meet and mingle with other NARFE members from across the state. And the location this year makes for a good place to visit. You can get the Registration Form from me at the next meeting, or in the Tennessee Federation Newsletter, or online at the Federation website which is listed below. Let me know if you are interested in going or you need any details.

We have received 1 Resolution to be considered at the Federation Convention. This Resolution would make changes to the Federation Constitution and Bylaws in regards to the Federation District Officers. It would change the title of this position from District Officer to Congressional District Liaison and change that instead of being appointed by the Legislative Chairman, the Federation President would appoint these officers.

This resolution is being submitted by the Federation Board and the purpose of the name change is to agree with the implementation of the new Strategic Planning Process being done on the national level. The stated purpose for being appointed by the Federation President is to make it somewhat easier to find and fill these positions with qualified individuals.

We will discuss this at the meeting this month and decide whether to support or not support this change. This is a minor change and my main concern is: The current Constitution and Bylaws went through a big revision last year and it might be best to hold off on this change until there are more items of change to be considered.

### Member Death

I just learned that we lost another member of our chapter. Dixie Bilyeu passed away at age 76 on February 29th. Dixie lived in Hilham TN and attended our meetings several times and our picnics when she was able.

She was a retired federal employee and worked as a computer programmer. I am not sure which agency. Dixie is survived by a sister, a brother, 2 step-daughters and several step-grandchildren. Her husband, Richard Bilyeu preceded her in death. Our sympathy goes out to the family.
