**.National Conference and Voting**

Since the NARFE national association is changing this year from a bi-annual convention to a bi-annual conference, the voting process will need to be changed. Each member individually now has the responsibility and the right to vote on the matters of business as well as for the national officers.

The voting will be done by ballot which as far as I know now will be published in the June issue of the magazine. The March issue contained the list of candidates running for various national offices along with their candidate statements. The April issue contains a list of Bylaws changes and Resolutions which members are to vote to approve or reject. Also on the NARFE website, there is a section on the upcoming voting with this same information and more.

To access the voting information on the website, go to narfe.org and log in with your last name and members ID number. Look at the moving banners near the top of the page, and click on the one with the 2018 Balloting Information. Here you will find the latest information. There has been 4 other voting issues added that are not shown in the magazine as of now. The Committees have gone over all the changes submitted and condensed them down to the current list and added their recommendations if they should be approved or rejected. But each member should read about what the changes are and decide for themselves if you want to vote to approve or reject.

The same for the list of officers, there are 4 candidates running for National President and 2 candidates running for National Secretary/Treasurer. We in our chapter will also cast a vote for 1 of the 2 candidates for Region X Vice President. I will report more details on this in May and June.

### Legislative News

A new Postal Reform bill has been introduced in Congress. I am copying in part, the information on it which was contained a recent .NARFE Legislative Hotline message. Some of you may have already received it.

Sen. Thomas Carper, D-DE, introduced S. 2629, The Postal Reform Act of 2018 on March 23

The bill would require current USPS retirees to enroll in Medicare Part B in order to continue receiving their current health insurance coverage through the FEHB Program, ultimately raising their overall health insurance premiums an additional \$1,600 or more per year, despite the fact that they previously declined this coverage.

The goal of this requirement is to decrease USPS health insurance costs by shifting primary responsibility for retiree health care costs from USPS to Medicare. This shift in responsibility would cost taxpayers \$10.7 billion over 10 years.

NARFE opposes the bill because it unfairly burdens tens of thousands of postal retirees and their survivors by changing the bargain regarding their health benefits after retirement, removing choice with regard to their health care and setting a dangerous precedent for all federal employees and retirees. However, S. 2629 does contain several improvements over the leading House postal reform bill, H.R. 756, Postal Reform Act of 2017, that would address circumstances that NARFE found particularly concerning and had stressed to members of Congress. First, S. 2629 includes an exception for those living in a geographic area "in which there is a lack of participating Medicare Part B providers." This allows those who retired overseas, for example, where doctors do not accept Medicare to be exempt from the new requirement. Second, it includes an exception for those who "would not derive benefit from enrolling in Medicare Part B because of comprehensive medical coverage provided by the Department of Veterans Affairs or other programs." Both of these provisions prevent the bill from imposing a new cost without any benefit at all for the postal retirees in question.

NARFE members must act now to prevent this legislation from becoming law. We encourage members to write and call their legislators and urge them to vote "no" on S. 2629 and H.R. 756.
