Here is the latest statement regarding reopening of the NARFE national office: [In response to Governor Ralph Northam announcing that nonessential businesses in northern Virginia can reopen on Friday, June 12, as part of the state's phase two response to the COVID-19 pandemic, and in accordance with directives issued by local government and health authorities, NARFE National Headquarters will implement a phased reopening beginning Monday, June 22.](#)

["As it has been since the onset of the COVID-19 pandemic, the safety and well-being of NARFE employees and the broader federal community continues to be the association's top priority," said NARFE National President Ken Thomas. "Now that it is safer to resume business operations in a more traditional setting, we are instituting a maximum flexibility approach that includes the opportunity for telework and allows for flexible work schedules to accommodate the various and unique personal, medical and caregiving needs and situations that our employees face."](#)

[NARFE's return to work plan specifies that, effective June 22, employees will be able to return to the office on staggered schedules, currently furloughed employees will be recalled, and the entire staff will not be on premises at full capacity until September.](#)

["It's essential that NARFE employees return to work knowing they are conducting business in a safe place. To that end, professional industrial hygiene cleaning services have been applied throughout the headquarters building, and employees will be provided with a comprehensive outline of measures to protect themselves, colleagues and common workspaces," continued Thomas.](#)

## The Check is in the Mail

Since some of our Chapter 1956 members were overcharged and overpaid the chapter portion of membership dues during 2019, refund checks have been issued. I was able to identify 20 members who were due a refund and those 20 will receive a check this month from our chapter. Our Treasurer, Myrna Estes has written the checks and they will go out in the mail, either with this newsletter or a separate mailing to those who get the email version of the newsletter. Of the 20, most will receive a refund of \$4, while some will receive \$8 or \$12.

You need to know when renewing your membership dues if you are billed from the national office, the correct amount of dues should be \$46 if renewing for 1 year, or \$84 for 2 years, or \$120 for 3 years.

Those of you who are on Dues Withholding, please check your records with OPM and make sure that \$3.34 per member is being withheld from your annuity check. (In some cases both the member and spouse are on Dues Withholding.)

All the overpayments that I have found were in 2019. So far, I have found none in 2020. If you have questions, do not hesitate to ask.

## Upcoming NARFE Voting

Refer back to the June/July magazine for a list of the proposed Bylaw changes that will be on the ballot and March magazine for officer candidate statements. All of this is online as well on the NARFE website.

The official ballot will appear in the August magazine which you should receive in the mail in the latter part of July. You will have till the end of August to submit your ballot by mail or online.

There is a 37 page booklet which explains the many proposed ballot issues. I can provide a electronic version of that for you upon request. On the ballot, we will see the National Officers to be voted on and the Region Vice President. Most of us are in Region X but we do have some members in other NARFE Regions.

My recommendations for National Officers are as follows. Ken Thomas, the current President is running unopposed. I recommend a vote for him. Of the 2 candidates for National Secretary/Treasurer, I recommend Cindy Renee Blythe rather than Kathryn Hensley. For Region X Vice President, I recommend Robert Allen over Bill Shackelford. But of course, the decision is yours to make. Hope you will vote.

## Annual Chapter Awards

Each year the Tennessee Federation recognizes the chapters within the state that made the most donations to Alzheimer's research and to the NARFE-PAC. This year the winners are: The Weida White Tolley Alzheimer's Award goes to the Cleveland Chapter and the Leo Potts NARFE-PAC Award goes to the Chattanooga Chapter.
