### August is Advocacy Month

This month is a good time to meet with your members of Congress. They generally come back to their district and state during the month of August. Even though this is not an election year, there still should be some events nearby where our Senators and Representatives will hold meetings. I do not know when that will be where you live, I would recommend that you watch local news and whatever is available to find out when meetings are going on near you.

Of course you can speak with your elected officials on any topic, NARFE encourages you to speak to them regarding legislation pertaining to federal workers and retirees. You can find help on these topics on the NARFE website. Click on the section called Advocacy and there you will find listed several ways that you can take part.

### Members Still Being Overcharged

I have just found out that some of our members were overcharged for chapter dues again. This happened last year and I contacted someone at NARFE headquarters to attempt to get it resolved but was not successful. As you may remember, we as a chapter ended up sending refund checks to those who were overcharged. For most, the amount of the overcharge was \$4.00. There is was no problem in the National portion of the members dues.

On the July financial report, I see 4 members who use dues withholding that are being overcharged this year. I contacted a different person from last year and this person has assured me that she has gone in to their system and manually corrected the problem. I hope so, but I have no way to verify this for you.

For those on dues withholding, each year on the anniversary date of the time that you enrolled in dues withholding, OPM will send you a Annuity Statement if there is a change. The amount for NARFE dues shown should be \$4.00 each month. This is for national and chapter dues. I believe some will show \$4.33 which is incorrect. The person I spoke to was to correct this, but I would ask that you log in to your OPM account and check the amount of the NARFE withholdings from your monthly payment.

I will continue to monitor this in the months to come and if the problem persists we will try to refund the overcharge. Please bear with us on this.

### Biden Issuing Vaccine Mandates

President Biden has said that he will force all federal employees to be vaccinated against COVID-19. While many federal employees may already be vaccinated, I think this should be left up to each person to decide. We should have personal freedom and this should not be mandated on anyone. What will follow, will he also mandate that retirees be vaccinated?

### Legislation Report

In previous newsletters I have made mention of several important bills that have been filed in Congress. This month I want to mention 1 other.

It is named, the Social Security Fairness Act H.R. 82 and S. 1302. Similar bills have been around for many years that would fully repeal the Windfall Elimination Provision (WEP) and the Government Pension Offset (GPO). This current bill continues that effort and it would benefit those federal employees who also receive Social Security benefits. Currently there are 175 Cosponsors for H.R. 82 and 29 Cosponsors for S. 1302 as reported in the August magazine.
