### National Officer Candidates

There is always a lot of interest in those who want to be NARFE national officers. These are elected by members every 2 years and this is the year for that.

These include the national president, national secretary/treasurer and a vice president for each of the 10 regions throughout the nation. We in Tennessee are in Region X and that is the only region that we have a vote in.

These national officers will be vote on by ballot prior to the 2022 National Conference (FEDCON as it is now called). The ballot will be included in the NARFE magazine in an upcoming issue around June or July.

The candidate statements are included in the May issue of the magazine, I encourage you to read what each one has to say about themselves and what they want to do as an officer. I would also like to make a few comments about some of them.

There are 4 candidates for National President and I have to say that I am not impressed by either of them. They are

- Bill Austin who was several years ago our Region X Vice President.
- Jon Dowie who was a previous National Secretary/Treasurer
- Gary Roundtree the current Region II Vice President
- William Shackelford our current Region X Vice President.

I will be giving more thought to each of these but at this point I cannot recommend either of these for National President. Consider what your choice is.

There is only one candidate for National Secretary/Treasurer and that is the incumbent Kathryn Hensley. As far as I know, she is doing a good job in that position.

There are 2 running for our Region X Vice President position. They are:

- Robert Allen who I highly recommend and was a past North Carolina Federation President.
- Charles Talley who is a North Carolina Federation Vice President.

### FEDCON 22

This is also the year for the NARFE National Conference, now called FEDCON. It is 2 and a half day event that will take place in Scottsdale AZ on August 21-23, 2022. More information will be included in the magazine as the dates gets closer.

Prior to the National Conference be on the lookout for a ballot to be included in the NARFE magazine that will list the Officers, proposed Resolutions and By-laws changes to be voted on. You can mail in the ballot or go online and vote by that means. Instructions will be included and a phone number for questions will be shown on the ballot.

### Legislation News

The NARFE supported Postal Reform Act of 2022 was signed into law on April 6th after passing both houses of Congress. This version of the bill included provisions that were better than previous versions of postal reform.

The act establishes the Postal Service Health Benefits (PSHB) program, which will be administered by the Office of Personnel Management (OPM) and made available to postal employees and annuitants in January 2025. While most current postal employees (future retirees) will be required to enroll in Medicare Part B at age 65 as a condition of coverage, current postal retirees (as of January 1, 2025) will not face the new mandate thanks to NARFE's advocacy. However, current postal retirees will have the opportunity to enroll in Part B without a late penalty through a special six-month enrollment period starting April 1, 2024. Plans in the PSHB will be designed to mirror current Federal Employees Health Benefits (FEHB) program plans but with different rates that reflect a separate, postal-only risk pool as well as cost savings accrued from increased Medicare integration.
